### Diablo Valley Montessori School Field Trip Driver-Chaperone Agreement

I hereby offer to provide transportation and supervision for students and adults of Diablo Valley Montessori School for the following field trip:

I hereby acknowledge and confirm the following:

1. I possess a current and valid California Driver's License and have provided a copy of the driver's license to the office.
2. I carry liability insurance in the amount of \$\_\_\_\_\_. (The minimum liability insurance required by the State of California is \$15,000 for injury liability for one person in an accident , \$30,000 for all injuries in an accident, and \$5,000 for property damage in an accident). I have provided a copy of my insurance to the office and will update DVMS if any information changes prior to driving on any field trip.
3. I agree to drive in a safe and cautious manner. Driving in a safe manner includes, but is not limited to:
  - a. Only using a mobile device in hands-free mode
  - b. No texting while driving
  - c. Following all posted speed limits
  - d. Never using anything that could impair my judgment (such as alcohol or sleep inducing medications)
4. In the event of an accident or injury during a field trip I will notify DVMS immediately.
5. I will carry no more passengers than my vehicle is designed to carry.
6. I understand that field trips are solely for DVMS students. Other family members, including siblings, will not attend.
7. I have a clean driving record indicating no traffic violations in the past 3 years. I will notify DVMS should my driving record change as a result of any traffic violations. If I attend traffic school to clear my driving record then I may drive on a field trip. I give DVMS permission to review my driving record before I drive any DVMS student on a field trip.

8. All passengers in my vehicle will wear seat belts. Children aged 8 or under will use child car seats appropriate for their age and weight as required by California law. If a child riding in my vehicle is using a car seat that is not provided by the child's parents, I will notify, or be sure the child's teacher has notified the parent and determine that the child is riding in a car seat appropriate for their age and weight and is in compliance with California law.
9. I will drive directly from DVMS to the field trip and back with no stops (errands etc.)
10. To be respectful of other families' choices,
  - a. I will only play age-appropriate, non-explicit music in the car while transporting DVMS students.
  - b. Videos will not be played on any device while DVMS students are in the vehicle.
  - c. No food or beverages will be provided by me for DVMS children while in my vehicle or during the field trip. Each child is responsible for their own food and beverage.
  - d. If the field trip is at a venue with a gift shop or other shopping opportunities, I will not purchase items for any DVMS students in my care. Likewise, I will not purchase any items for my child while on the field trip.

DVMS reserves the right to decline offers of assistance from parents, guardians, and other volunteers, including but not limited to driving.

I hereby agree to the terms indicated in this form and I have read, understand, and agree to the conditions noted above. I will notify DVMS immediately if any of my information changes.
